- B. Product Data: Manufacturer's data sheets on each product to be used, including:
 - 1. Preparation instructions and recommendations.
 - 2. Storage and handling requirements and recommendations.
 - 3. Installation methods.
- C. Manufacturer's Certificates: Certify products meet or exceed specified requirements.
- D. Manufacturer's warranty.

1.5 DELIVERY, STORAGE, AND HANDLING

- Store products in manufacturer's unopened packaging until ready for installation.
- B. Protect materials from exposure to moisture. Do not deliver until after wet work is complete and dry.

1.6 WARRANTY

A. Provide the manufacturers 2 year limited warranty on electrical components.

 - 1. Provide all components and accessories required for a complete, functional unit.
 - 2. UL or CSA listed.

 - 2. Description: Realistic 50" wall-mounted linear electric fireplace
 - 3. Dimensions:

- 11. Optional Media Bed Accessories:
 - a) Driftwood and river rock accessory package (includes one large and one small piece of driftwood, with loose rocks)
- 12. Optional Trim Kits:
 - a) Cohesion Surround Black
 - b) Cohesion Surround Burnished Walnut
- 13. Control options:
 - a) Multi-function remote control
 - b) Built-in membrane controls (Flame on/off, heat on/off, thermostat, colour options)

PART 3 EXECUTION

3.1 INSPECTION

- A. Do not begin installation until substrates have been properly prepared.
- B. If substrate preparation is the responsibility of another installer, notify Architect of unsatisfactory preparation before proceeding.
- C. Verify proper power supply and fuel source are available.

3.2 PREPARATION

- A. Clean surfaces thoroughly prior to installation.
- B. Prepare surfaces using the methods recommended by the manufacturer for achieving the best result for the substrate under the project conditions.

3.3 INSTALLATION

- A. Install in accordance with manufacturer's instructions and requirements of authorities having jurisdiction.
- B. Use manufacturer's guidelines for minimum clearances to combustibles, walls, and finishes.
- C. Anchor all components firmly in position for long life under hard use.
- D. Upon completion of installation, visually inspect all exposed surfaces. Touch up scratches and abrasions with touch up paint recommended by the manufacturer; make imperfections invisible to the unaided eye from a distance of 5 feet (1.5 m).

3.4 PROTECTION

- A. Protect installed products until completion of project.
- B. Touch-up, repair or replace damaged products before Substantial Completion.
